Terms & Conditions

Please read these competition rules carefully. By participating in the contest, you understand, acknowledge and unconditionally agree to abide by the following Rules:

1. To enter a competition you must be 18 years old or over at the time of entry, residing in South Africa in Tembisa and Diepsloot townships in Gauteng.
2. Competition is not open to employees (or members of their immediate families and friends) of Mabebeza.
3. Purchase of items over R100.00 is necessary to enter the competition.
4. Only one entry per person.
5. If you want to enter a competition you must upload a **colour photo** of your baby between 0-18 months, including receipt number of purchase of at least R100 leaving your full name, baby's full name and email address and cellphone number.
6. By submitting an entry to the competition, participants confirm that they are the legal and/or beneficial owner or otherwise have the intellectual property rights to submit/utilise such materials; and therefore, warrant that they have obtained rights in incorporating copyrighted materials i.e. images in their entry. 10. Every image uploaded is subject to a moderation process before it becomes visible on the contest page. Better Photography reserves the right to assess and disregard any submitted photo at our its discretion.
10. Each contestant is required to attend three (3) promotional events or appearances, time & dates to be determined.
11. Each shortlisted finalist will be required to participate in two (2) rehearsals leading up to the pageant – For a NO Show; you shall be penalised with a five (5) point automatic deduction from your score. No exceptions!
12. The winner will be chosen from the shortlist per Store and announced at the contest.
13. The closing date is as specified in each competition, and Mabebeza reserves the right to amend the competition end date at any time.
14. If you win the competition, we will notify you by or e-mail The judges' decision will be final, and no correspondence will be entered into.
